### Simavita releases ASX Appendix 4C for the quarter ended September 30, 2019

**Sydney, Australia** – Simavita Limited (ASX: SVA) today reported its September 30, 2019 quarter end results.

- Simavita continues to tightly manage ongoing operating costs with total cash outflows for the quarter of \$1.09m. This is an increase of 10% on previous quarter. Quarter on quarter there was a \$143k increase in corporate costs which included legal fees associated with capital raising, audit fees and increased overseas travel for licensing discussions.

Forecast cash outflows for the coming quarter are \$1.24m including additional commercialisation costs.

- Simavita ended the quarter for the period to September 30, 2019 with cash reserves of AUD\$352k.
- On 24 June 2019 the Company received the approval of shareholders at a Special General Meeting for a \$3.14m financing by way of Convertible Notes. \$2.14m of these funds have been received. The Company has now met the various milestones required to receive the \$1m balance of funds.
- The Company's focus for the following quarter is to:
  - Progress key commercialisation activities in major markets
  - Focus on sales and marketing
  - Continue software development for key Apps
  - Deliver key product lines in conjunction with manufacturing partners
  - Continue strategic field testing with partner organisations
  - Progress activities associated with a reorganisation of the Company including branding

- The Company continues dialogue with a number of major organisations with specific interest in our platform technology. These discussions are often complex, relate to major installations and may be of varying duration. The Company is committed to informing our shareholders and market should these discussions translate into signed agreements that are material to the Company and its operations.
- The Company expects to have negative operating cash flows for the time being. It should be noted that the Company continues to enjoy the support of its major shareholders. If required, the Company will raise additional cash to fund operations and to meet its business objectives.
- The Company confirms that it continues to be in compliance with Listing Rules 3.1 and 12.2.
- The above statements have been authorised and approved in accordance with the Company's published continuous disclosure policy.
